#### The Minister of Forestry and Mines,

Pursuant to the Constitution of the Republic of Rwanda of 04 June 2003, as amended to date, especially in Articles 30, 31, 32, 49, 120, 121 and 201;

Pursuant to Organic Law n° 04/2005 of 08/04/2005 determining the modalities of protection, conservation and promotion of environment in Rwanda, especially in Articles 38, 40, 50, 52, 53, 61, 64, 82, 94, and 96;

Pursuant to Law  $n^{\circ}$  47/1988 of 05/12/1988 determining the Organisation of Forests in Rwanda, especially in Articles 29, 30, 31, 35, 36, 37, 38, 74, 75 and 77;

After consideration and approval by the Cabinet, in its session of 05/03/2010;

#### **HEREBY ORDERS:**

#### Article One - Declassification of Kanembwe Forest

Kanembwe Forest of two hundred eleven (211) hectares, seventy seven (77) acres and eighty six (86) centiares situated in the Western Province, Rubavu District, Rubavu Sector is hereby withdrawn from classified forests.

#### Article 2 – Repealing provision

All prior provisions contrary to this Order are hereby repealed.

#### **Article 3 - Commencement**

This Order shall come into force on the date of its publication in the Official Gazette of the Republic of Rwanda.
